Grant of permission to run/establishment of a private educational institution.

Sir/Madam,

On the careful consideration of the inspection report submitted by the Inspection Committee District Kangra H.P. vide letter No. EDN-KGR- (G-5)/NOC/2018-3543-44 dated 25-06-2019 constituted for the purpose of inspection of Private Educational Institutions of the School level for grant of permission to run/establish a private educational institution by the Govt. of H.P. Shimla vide Notification No.- Shiksha-II-Chha (11)-2/2005-L dated 03-05-2006 and in exercise of the powers vested in me vide Govt. Notification No. Shiksha-II-Chha (5)-3/97 dated 16-01-2007, the approval of competent authority with regard to issue of Permission for establishment/running/up gradation of private Educational Institution in respect of "Lawrence Public School Education, Society located at Rehlu Road, Shahpur, Tehsil Shahpur, District Kangra, H.P." registered under as per the provision of Registration Act. 2006 (Registration No: 56/2010/SDM-MC) dated 25-09-2010 for the establishment of "Lawrence Public Senior Secondary School Shahpur, District Kangra Himachal Pradesh-176206," for +1 to +2 (Science, Commrece and Arts Streams only) classes from the academic session 2020-21 (if the affiliating Board find fit) is conveyed subject to the following terms and conditions:-

- 1 That the school concerned shall be affiliated to Central Board of Secondary Education Shiksha Kendra-2, Community Centre, Preet Vihar, Vikas Marg, Delhi-110301 +1 to +2 (Science, Commerece and Arts Streams only) classes.
- 2 That the State Govt. will not provide any type of financial assistance/Grant-in-aid etc. in respect of the said institution.
- 3 That the admission in the institution shall be made strictly in accordance with the norms as laid down by the Board of School Education to which the school is affiliated and no discrimination on the basis of caste, colour, creed and sex shall be made. No pupil shall be refused admission on account of his caste, creed or religion.
- 4 That the private institution shall employ only the trained/eligible staff as per the norms fixed by the Govt.
- 5 That no particular religious education shall be impacted by the institution to maintain secular character of the institution.
- 6 That the fees and funds shall be such that they are not of exploiting nature but contribute to the spread of education. They should be commensurate to the salary of the staff being paid, development of infrastructure and facilities and activities being provided to the students. (Donation in any form from the student is strictly prohibited).
- 7 That the permission to run or establish a private educational institution shall be granted only on individual basis and the institution shall not be entitled to open its branches elsewhere.
